### Chelsea Weedman in San Diego County Swim Meet

RANCHO PENASQUITOS CA — Anyone wanting a sneak peek of what the CIF San Diego Section swim meet will look like later this year had their chance Saturday at the Sundevil Invitational at Mt. Carmel High.

There were 18 schools and more than 500 competitors at the annual event, which is considered the region's top regular-season invitational in boys and girls swimming.

"This invitational really gives you a chance to see how you're going to respond to top competition," said Mt. Carmel coach and event organizer Dan Peck. "I think this is indicative of what you're going to see at CIF."

It figures then that county powerhouses

like Carlsbad, which has won seven consecutive CIF Division I titles in boys swimming, and Cathedral Catholic, which has two straight CIF Division II titles in girls competition, were there soaking up the sun and early-season success the event offers.

Carlsbad coach Jim Barton said he was "pleased" with his team's swimmers, especially standout Colin Smith. Smith, who led the Lancers' water polo squad to the Division I title last year and broke the school's record for goals in a season with 146, flourished in the 100-yard butterfly and 200 freestyle events. The senior placed sixth and seventh, respectively, in those races at last year's CIF Championship and is hoping to make great strides this season.

"For me, I just like to see my times getting better," Smith said. "Winning right now isn't necessarily the goal."

For a standout like Cathedral's **Chelsea**

## **Hannah Weedman Named Illinois All State Class 1A Basketball Player**

February 23, 2010. The news **Hannah Weedman** had been waiting for arrived Tuesday.

The Knoxville High School center was named Associated Press first-team all-state in Class 1A after averaging 14.7 points, 8.1 rebounds and 6.7 blocks this season for the sixth-rated Blue Bullets.

"I made honorable mention last year so it's quite a big jump," said the 6-foot-4 Evansville recruit, who helped guide Knoxville to a 24-7 season. "Yeah, I'm surprised because there's a lot of talented girls in the state of Illinois."

Monmouth-Roseville senior Rebecca Gillen was named second team in Class 2A while Ridgewood junior Ella Teel was honorable mention in Class 1A.

Gillen averaged 15.1 points, seven rebounds and three steals for the Titans. "She's a four-year starter for us so she basically knew what we wanted to do on the floor," Monmouth-Roseville coach Jim Cole said. "With her athletic ability, she had to go up against a lot of girls bigger than her and she was still able to score 15 points a game."

A guard, Teel leads third-ranked Ridgewood (31-2) in scoring at 11.2 points and has been a driving force for a Spartans team that will play in the state semifinals this weekend at Redbird Arena in Normal.

Knoxville coach Matt Gibson said **Weedman** is the first Knoxville girls basketball player to earn first-team all-state honors. Haley Jones earned honorable mention all-state in 2008. "Teams played us 95 percent of the time zone and that had everything to do with Hannah," Gibson said. "Everybody's No. 1 goal was to stop her and see if the rest of our players could score."

A four-year starter, Weedman was joined on the first team by Brimfield's Paige Spietz, Annawan's Kelly Buresh, Hinckley-Big Rock's Jenna Thorp and Savannah Piety of Fisher.

"I was just trying to do the best I could this season, just knowing that it was my last," Weedman said. "Making a state team should be every girl's goal."

**William Weedman**, 77, of Carmi, passed away Monday, March 1, 2010, at the Jefferson Barracks VA Hospital in St. Louis, Missouri.

He was born Sept. 19, 1932 in Maunie, the son of **Samuel George** and **Jessie Mae (Erwin) Weedman**. William was a member of both the American Legion and VFW. He was a member of the Eastside Pentecostal Church. William was an avid Cardinal fan.

The descendants of **Henry Linas** and **Cynthia (Reed) Weedman** will have a Reunion on July 17, 2010 on the home place of **Larry Picht** in Holloway, Minnesota. If you are a descendant of this family and can participate, contact one of the organizers shown below.

**Henry Linas Weedman** was born 8 November 1850 in DeWitt Co., IL and was the sixth of ten children of **Asa** and **Delilah (Hand) Weedman**. Following the death of Asa, the family moved to the Webster City (Hamilton County), Iowa area. Delilah remarried and the family found their way to Miami County, Kansas where Henry married **Cynthia Reed**. The family seemed to go back and forth between Iowa and Kansas. Today, descendants are found in Kansas, Minnesota, Iowa and on the West Coast.

**Henry** and **Cynthia Weedman** had a large family – fourteen children – and as a result there are a large number of descendants today.

A Reunion was held in 1997 for which **Carol Rohloff** prepared an outstanding book that gave details of all of the descendants including many excellent photographs. We have displayed this book at every Reunion we have attended since 1996.

### **Elizabeth Weedman Murphy Daughter of Christian, Sr. and Elizabeth Weedman**

Mentioned in the will of **Christian Weedman, Sr.** that was made and probated in 1811 in Fairfield County, Ohio was a daughter, **Elizabeth Murphy**. A number of researchers have attempted over the years to determine who she married and what happened to her.

In making preparations for the 2008 Weedman National Family gathering in Uniontown, Pennsylvania, we reviewed the records of Jacobs Lutheran Church near Masontown, PA.

We found a **Joseph** and **Elizabeth Murphy** who had two children christened in that church in the time frame the family lived in the area. The two children were **Johannes** born 21 September 1795, christened 29 October 1795 with **Michael** and **Barbara Riffle** serving as sponsors. The second child was **Christian** born 12 October 1796 and christened 20 November 1796 with **Philp** and **Magdalena Maurer** serving as sponsors.

The names of the children are interesting and while not any proof of relationship with **Christian** and **Elizabeth Weedman**, it is probably a strong hint at the least. The traditional German method of naming children was that the first born

son is named in honor of the paternal grandfather while the second son is named in honor of the maternal grandfather.

In the 1790 Fayette County, PA census, a **Joseph Murphy** is found living in Springhill Township which is just south of what was then German Township. He is the sole individual in the household and is a male aged 16 years or more. There were 10 different Murphy listings in the 1790 Fayette County, PA census but only two, **William** living in German Township, and **Joseph** in Springhill Township were in close proximity to the Weedman family. **William** appears to be too elderly to have married **Elizabeth** who we believe to have been born between 1767 and 1770.

In the 1800 census, we find the **Joseph Murphy** family living in German Township. There is one male between 26 and 44 years old with two males under 10 as well as one female between 26 and 44 years old.

There is no listing that can be found for **Joseph** in the 1810 Pennsylvania census.

It is not unreasonable to assume the family left Pennsylvania for Ohio with the rest of the family. If this is the case, we find a **Joseph Murphy** living in Madison Township, Licking County, Ohio in the 1820 through the 1850 census records. In addition, we find that a **Joseph Murphy** married a woman named **Praise** (surname not shown) on 19 December 1813. Tracing this family through 1850, we find **Joseph Murphy** at age 75, born in Maryland, living with his apparent son, **Charles Murphy**. This **Joseph Murphy** born about 1775 is probably too young to be the husband of **Elizabeth Weedman** but such a marriage is not impossible.

It would appear that **Elizabeth** must have died between the 1811 drawing of the will of her father, **Christian Weedman, Sr.** and 1837. There is no mention of **Elizabeth** or her children in the 1837 lawsuit (**Nicholas Weedman** versus **Jacob Keefover** regarding the estate of the late John Weedman).

We have attempted to trace **Christian Murphy** and **Johannes** or **John Murphy** with no success. It is reasonable to assume they died as well. Recently we heard from **Belinda Marcum** who is tracing **Joseph Murphy** also known as **Joseph Faverty**. **Faverty** was born in Paris, France on September 25, 1753, immigrated to the U. S., and was in the Revolutionary War. After the War, he settled in Springhill Township, Fayette County, PA. Springhill is immediately south of what was then German Township where **Christian Weedman** lived. Somehow **Joseph Faverty** got a nickname of **Joseph Murphy** and he went by that in the Revolutionary War and afterwards. In his pension application, he stated he didn't know how he got the Murphy nickname.

**Joseph Murphy** (aka **Joseph Faverty**) married a woman named **Elizabeth Wedman** about 1793 in Fayette County. There were six children born to this couple including: **Joseph, Jr.** (1794), **Mary** (1796 and died in infancy), **Christopher** (1798 – died in infancy), **Joshua** (1800 – died in infancy), **John** (born 1802 in Scioto Co., OH) and **Elizabeth** (1804 in OH). We are unsure of the source of the birthdates of these children. A genealogical work on **Joseph Faverty** was compiled in the 1980s by **Arnold Faverty** and he is likely the one who determined these dates.

Note that the dates are in conflict with

the baptismal records of the two children of **Joseph** and **Elizabeth Murphy** from the Jacobs Lutheran Church records. However, until the source of the birth information above can be confirmed, we should not dismiss this information out of hand. We have found information that states that **Joseph Faverty, Jr.** was born in 1800 making one question the accuracy of the dates.

We have searched the 1790 and 1800 census records for Fayette County, PA and cannot find any family living in Fayette County that has a surname even close to that of **Elizabeth Wedman** except for our **Elizabeth Weedman**.

According to **Mrs. Marcum**, in 1801 **Joseph Murphy** bought land in Scioto Co., Ohio and in 1802 floated down the Ohio River to Portsmouth, Ohio where the family settled. In 1834, **Joseph** filed for a Revolutionary War pension but his plea was denied. Unfortunately, nothing in this pension application reveals family connections.

Is this our **Elizabeth Weedman** or not? The information at hand seems to suggest it is but there are three factors questioning this conclusion. First, the dates for the birth of the children from records of the Jacobs Lutheran Church in German Township, Fayette County and those in the work apparently from **Arnold Faverty** conflict. Second, the failure of Elizabeth or her children to be revealed in the 1837 lawsuit in which all of the other known siblings of the then late John Weedman are named is troubling. Finally, we know two children were christened in the Lutheran Church but we are told that **Joseph Faverty** was a Catholic and raised his children in that faith which again presents conflicting information.

How will we ever sort this out? A deeper search of County records in both Fayette County, PA and Scioto County, Ohio might be helpful but it is likely that **Arnold Faverty** already accomplished this. One other tool would be DNA testing. However, this is complex because you would have to test direct female lines from the **Elizabeth Weedman Faverty** descendants and compare those to direct female lines going back to Elizabeth Weedman, the mother of Elizabeth who married **Joseph Murphy**. This is complicated by the fact that our records tend to be heavily skewed toward the male lines since it is easier to trace the Weedman surname than it is the daughters and their daughters and theirs, etc.

In conclusion, we believe that **Elizabeth Weedman** who married **Joseph Murphy** is probably the same of the **Elizabeth Weedman** who married **Joseph Murphy** or **Joseph Faverty**. If someone wanted to work on proving this probably through DNA testing, it would be both helpful and interesting.

## Myrtle Mae Weedman

**Randy McCoach** of Albuquerque, N.M. wrote looking for family information on **Melinda Darner** who was the second wife of **George T. Weedman**. George was a son of **Asa Weedman (Asa, John Huhn Weedman, Sr., George and Christian Weedman, Sr. line)** who was born in 1838 in DeWitt Co., IL. **George** was in the Civil War and married **Mary Carem** with who he had two children. After her death, he married **Malinda** or **Melinda Darner** in Miami Co., KS. One child, a daughter, was born to the couple and she was **Myrtle Mae Weedman** (Sept. 1882 – 1920). **Myrtle Mae Weedman** married **Luther Roberts** in 1906 in Miami County, KS and they had a large family. In 1920 **Myrtle Mae Weedman Roberts** died in childbirth and is buried in Miami County. Her photograph appears here courtesy of Randy. We were able to trace to Darner family back to Ohio and learned Malinda was the daughter of **Jacob and Elizabeth (Hull) Darner**. She is a cousin to **Dr. Daniel Wilson Weedman**, a well known astronomer, and advised that Dr. Weedman had furnished to the immediate family a copy of an autobiography written by his father,

**Roy Lee Weedman**, a number of years ago.

**Roy and Louetta Weedman** were frequent participants in the Weedman Family Reunions. He was an excellent and creative writer who supplied us with a family song and a poem about our family name. Both Roy and Lu Weedman died last year only months apart.

The autobiography is mentioned because it is a highly personal recollection of not only his family history but also his recollection of the Weedman family in the Grayson and Ohio Counties area of Kentucky. The work is over 60 pages long and thus too long to publish here. We would hope that more family members would document their recollections of their past and their family history for future generations to have. The use of video recordings of conversations can prove informational. Or, audio recordings, as **Kenneth Weedman** made could be quite interesting.

### **John Weedman Lawsuit**

*In the Spring 2010 issue of the Weedman Newsletter we provided details of the Elizabeth Weedman Murphy family. A subscriber stated that while it was interesting, the lack of knowledge about the early family left that person wondering about some details.*

*Many genealogical researchers look into census records, vital statistics, probate records, newspapers, etc. to find as much information as possible. But, there are other sources of family information hidden in court records. Here, we will detail a lawsuit which describes in detail the early family structure of the Christian Weedman, Sr. family.*

**John Weedman** was the sixth child and second son of **Christian, Sr.** and **Elizabeth Weedman**. He was born circa 1772 in Fayette County, PA. He doesn't appear in any of the Fayette County tax lists that we can find and thus know little about his early life.

In 1799, **Christian** and **Elizabeth Weedman** sold the homestead, "New Holland", to a couple of neighbors and apparently departed Fayette County. It is unclear where they went prior to their relocation to what was then Hopewell Township of Fairfield County, Ohio about 1806.

However, from early histories of Licking County, OH it has been learned that **John Weedman** was an early settler arrived there in 1801. It is believed that he remained there until his death about 1836 or 1837. He was believed by many to have been an old bachelor, but histories and court records show a different story.

Here is an excerpt from a Licking County,

OH history entitled, "*Pioneer Papers No. 17*", by Dr. J. N. Wilson:

"...I will mention that this **John Weedman** owned one of the three or four horses that were stolen by the Indians in April after his arrival. The Indians were pursued by Ratliff, Hughes and Bland, overtaken and killed, and the horses brought back. In 1805, we find that this Weedman had purchased 160 acres of land in the refugee tract, near the Perry County line in this county, where he resided some thirty years, and in the mean time, his brother and sister came and settled near him. He was always considered by his neighbors a well to do old bachelor. He died suddenly in his house where he had lived alone. After his death, quite a sum of money was found; the money was sticking in the cracks of his log house, the silver in bags, stowed away in secret. His brother administered the estate (editor note: actually it was his brother-in-law) and he and his sister took possession of the farm supposing they were the rightful heirs; but some one after the death of **John Weedman**, wrote to a **Nicholas Weedman** who was living in Indiana, and who soon made his appearance in Newark (the county seat of Licking County) and made application to our well known fellow citizen, S. D. King, Esq. for the purpose of getting possession of the estate. His statement was that his father while a young man lived in one of the western counties of Pennsylvania, and that he had a love affair with a neighboring girl, but as the course of true love does not always run smooth, they had some difficulty which was settled by an unwilling marriage on his part. As soon as the wedding was over, John left for parts unknown, but turned up on the Bowling Green. Mr. King brought a suit of ejectment against **Nicholas Weedman's** newly discovered uncle and aunt. The trial came on but no one appeared to contest his right, so judg-

ment was obtained by default and he now came in possession of his father's estate, a father that he never saw or knew, much to his satisfaction, but the uncle and aunt thought it rather a hard bargain to give up a good farm to obtain a thirty five year old nephew..."

Despite a fire which destroyed many of the Licking County records, that of the lawsuit survived. In those records, **Jacob Kefover** was revealed to be the administrator of the estate of **John Weedman** and the estate was valued at \$977.13 (a considerable sum in those days!).

The suit reveals the wife of **John Weedman** was **Sophia Weedman** living in Indiana who relinquished any right to the estate. It states that **John** and **Sophia Weedman** were married in March 1792 and that **Nicholas Weedman** was the sole offspring of the couple. (**Nicholas Weedman** was born April 1, 1792).

Of great significance is the naming of the siblings of **John Weedman** who were shown to be: **George Weedman** of Illinois, **Jacob Weedman** of Indiana, **Christian Weedman** of Kentucky, **Adam Myers** and **Mary**, his wife, of Huron Co., Ohio and **Catherine Kefover** of Perry County, Ohio. In addition, children of deceased siblings are named: **Jacob Riffle**, **George Riffle**, **Elizabeth Riffle**, **Hannah Riffle**, and **Catherine Riffle** of Fayette County, PA (these are children of **Elizabeth Weedman Riffle** and her husband **Nicholas Riffle**, both deceased); and **Jacob Walters** of Illinois, **John Walters** of Ross County, OH, **Eli Walters** and **Naomi**, his wife, and **Mary Walters** whose place of residence is unknown.

Why is this important? It confirms the family structure of **Christian Weedman, Sr.** (with the exception of daughters **Elizabeth Weedman Murphy** and **Mar-**

There is a second lawsuit that is helpful in constructing some of the early family and that is one contesting the estate of **Catherine Kefover** who died in 1861 in Perry County, OH. We will print details of that law suit in a subsequent issue.

HEADQUARTERS 8TH MEDICAL BATTALION  
APO 8, U. S. Army

22 May 1945

SUBJECT: Commendation.

TO : Private First Class, Hershel R. Weedman, Company B,  
8th Medical Battalion.

It is with greatest pride and pleasure that this letter is addressed to you personally. The duties you have performed as a driver within your company and the battalion as a whole have made you one of the unsung heroes of this war. The hedgerows of Normandy, the Brittany Campaign ending in the conquest of Brest, the long trip through France to Luxembourg, the mud of the Hurtgen Forest, the battle for Cologne and the crossing of the Rhine, the battle of the Runr pocket, the long trip through Germany ending in the crossing of the Elbe and conquest of Schwerin have not stopped you from surmounting every difficulty. Under all conditions of combat, often under direct fire, and more than once under direct observation from the enemy and in danger of mines, you, together with all the other drivers in your company, have displayed endless courage and tireless devotion to duty. In spite of difficult road conditions, the strain of blackout driving and long hours without rest, men like you have carried on, often saving lives. In addition, you have kept the maintenance of your vehicles at such a high level that the maximum number of vehicles were always available for use.

It is recognized that motor officers, motor sergeants, and mechanics all have contributed to the enviable record this battalion has established, but the principal credit still belongs to the individual driver. Each one of you can be justly proud of the fine work you have done through all these long months of combat operations, and it is my privilege to share this pride with you. Perhaps you do not realize it, but your individual efforts have helped in no small way to contribute to the final crushing victory over the mighty German Army.

## History of U.S. Army 8<sup>th</sup> Infantry Division & Medical Battalion in WWII Private First Class, Hershel R. Weedman, Company B

- **07/01/1940** – Activation of the 8<sup>th</sup> Infantry Division, Ft. Jackson, S.C.
- **Summer 1941** – Field maneuvers in the Carolinas woods and fields.
- **Fall 1942** – Division participated in maneuvers in Tennessee & Missouri.
- **Summer 1943** – Division participated in maneuvers at Camp Laguna in Arizona desert.
- **12/05/1943** – Division sailed from New York Harbor to Belfast, N. Ireland.
- **12/15/1943** - Division landed in Northern Ireland and began 6 months training before the ETO ( European Theater of Operations ).
- **06/28/1944** – Four troop ships and Twelve Motor transports carried the 8<sup>th</sup> Division towards France.
- **07/04/1944** – Division landed on Utah Beach, Normandy, France ( one month after invasion ).
- **07/07/1944** - **Division enters combat.**
- **07/26/1944** – Division crossed the Ay River after fighting through the hedgerows of Normandy.
- **07/28/1944** – Division pushed its way down the western coast of Normandy.
- **08/08/1944** – Division pushed through Brittany & captured Rennes.
- **08/25/1944** – Division attacked the city of Brest until 09/11/1944.
- **09/19/1944** – Division drove across France to Luxembourg.
- **11/20/1944** – Division entered bitter Battle of the Hurtgen Forest.
- **11/28/1944** – Division cleared the city of Brandenburg.
- **12/03/1944** – Division pushed on to the Roer River.
- **02/23/1945** – Division crossed the Roer River.
- **02/25/1945** – Division captured City of Duren.
- **02/28/1945** – Division crossed the Erft Canal.
- **03/07/1945** – Division reached the Rhine River near Rodenkirchen and maintained positions at Cologne.
- **March 1945** – Division advanced into the Rhineland.
- **04/06/1945** – Division attacked northwest to aid the destruction of enemy forces in the Ruhr Pocket.
- **04/17/1945** – Under operational control of the British Second Army, drove across the Elbe and penetrated to Schwerin when the war in Europe ended.
- **05/02/1945** – Division advanced into northern Germany and encountered the Neuengamme concentration camp and Wöbbelin subcamp, near the city of Ludwigslust. The SS had established Wöbbelin in early February 1945 to house concentration camp prisoners who had been evacuated from other Nazi camps to prevent their liberation by the Allies. Wöbbelin held some 5,000 inmates, many of whom suffered from starvation and disease. The sanitary conditions at the camp when the Division arrived were deplorable. There was little food or water, and some prisoners had resorted to cannibalism. In the first week after liberation, more than 200 inmates died. In the aftermath, the United States Army ordered the townspeople in Ludwigslust to visit the camp and bury the dead.
- **05/07/1945** – Germany surrendered and operations officially came to an end the following day.
- **05/22/1945** – Lt. Col. MC, John M. Thompson in a personal letter commends Private First Class, Hershel R. Weedman, Company B, for his endless courage and tireless devotion to duty.
- **11/20/1945** – Division was re-deployed back to the United States and deactivated.
- In WWII service the 8<sup>th</sup> Infantry Division spent 266 days in combat. Total division casualties were 13,986, 2,852 of which were killed in action.
- **1988** – The 8<sup>th</sup> Infantry Division was recognized as a liberating unit by the U.S. Army 's Center of Military History and the United States Holocaust Memorial Museum.

It was while living on this farm that Elmer met his future bride and worked for her father as a farm hand for a couple years. On December 14, 1940 Elmer married **Donna Wreath** in Walnut Grove, MN and they made their home on a farm south of Milroy, MN. *We will all miss Gena and her numerous contributions to our family. Our condolences are extended to her family.)*

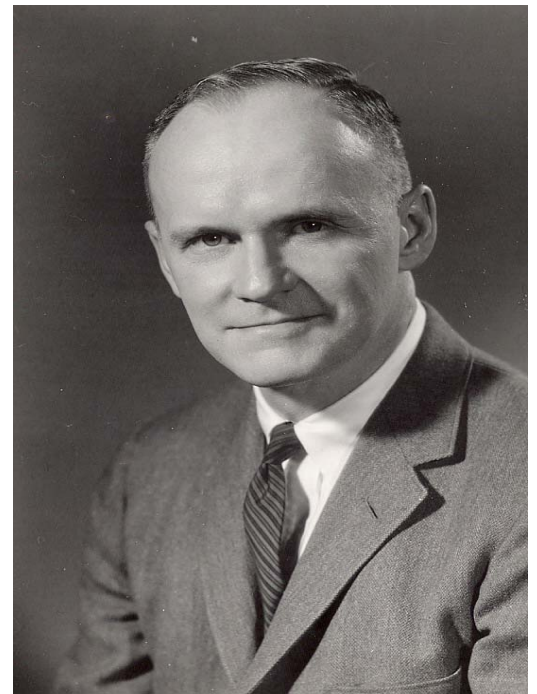

## George Thomas Weedman

Research by Randall McCoach

*(Randall McCoach is a journalist living in Albuquerque, NM. He made contact within the past year seeking information on his ancestor, **George Thomas Weedman**, and we were unaware of his intent to produce a highly professional and thorough study of descendants of this man. Here are excerpts.)*

**George Thomas Weedman** was born in May 1838 in Illinois. He lived in DeWitt County, IL for most of his early life and married **Mary E. Carew** there in 1860. He enlisted in Company G, 107th Illinois Infantry in 1862 and served for the duration of the war.

Following the war, he returned to DeWitt County and soon a family was begun. He and Mary had six children but only one,

**Phillip Sheridan Weedman** lived to adulthood.

**Phill Weedman** had a single daughter and moved from Hamilton County, IA to Shelby Co., MO and ultimately to south-east Kansas. This family cannot be located after being found in the 1830 Neosho Co., Kansas census.

The couple divorced with his wife complaining of excessive drinking by George. As a number of other family members did, he moved to Miami County, Kansas. There he married **Mary Adeline Tarrant** about 1877 but she lived only a few years dying on 21 February 1881. There were no children born to this couple.

On 15 April 1882, **George T. Weedman** and **Melinda Darner** married in Paola, Miami Co., Kansas. A single daughter was born to the couple, **Myrtle Mae Weedman**. She was born in 1883 in Hillsdale, Miami County, Kansas. By 1895, the family moved to Hamilton County, Iowa another location where a large number of Weedmans lived. But by 1905, they returned to Kansas and in 1906, **Myrtle Mae Weedman** married **Luther Roberts**.

At the age of 36, **Myrtle Mae Roberts** died giving birth to her seventh child, **Veda Roberts**. The child also died.

The family history goes on to provide details of all of the surviving members of the **Roberts** family and their descendants, with **Randall McCoach** being one. The work is well documented and Randall has been successful in finding family photographs which he uses very well.

The work is an excellent example of

### Find-A-Grave A Very Useful Genealogical Web Site

We have been able to make some significant genealogical discoveries of late through the use of a web site that gives burial information often accompanied with photos of tombstones. The web site is Find-A-Grave ([www.findagrave.com](http://www.findagrave.com)) and currently have over 55 million grave sites listed. Included in this total are currently 374 graves of Weedman family members.

Over the years, we have collected numerous photographs of tombstones and cemeteries but have not found a useful way of displaying those. Using Find-A-Grave as a repository for those photo-

graphs appears to have a lot of merit.

If your photographs are in a digital format such as a jpg file, it is quite easy to upload those to the Find-A-Grave web site. In addition to photographs, one has the ability to put obituaries and family information on the page with the photograph of the tombstones. If you don't have a photograph of a tombstone, you can still list the grave in the cemetery in which the burial site is located.

We were recently in contact with Scott Parish who lives in Weldon, Illinois which is located in DeWitt County, IL just southwest of Farmer City. We found that Mr. Parish had established a "virtual cemetery" for Weedmans and had about 75 of the family in his collection. Contact with Mr. Parish revealed his wife was related to Rachael Wilson Weedman, the wife of John Huhn Weedman, Sr. That contact stimulated our interest and we have subsequently created a Weedman Virtual Cemetery and well as one for the Brodix family.

In 2011, we will undertake a project of listing as many Weedman burial sites as we can with birth and death dates as well as photographs of tombstones if they are available. Where possible, we will show family relationships and show obituaries if those are available. This will make Weedman family information more widely available for those interested. Further, those additions will be included in the Weedman Virtual Cemetery on the Find-A-Grave site.

## DNA Project Update

Since our last report on the Weedman Family DNA project, there has been some progress to report.

The DNA project uses the latest in technology to use sophisticated DNA testing to show family relationships between those who have participated in the test. The test which involves having individual saliva samples analyzed by a professional DNA testing firm has been shown to be a reliable predictor of relationships between individuals.

So far, participating in the program are: **Earl Joseph Weedman** who is from the Florida Weedman line; **William Bruce Weedman** and Nick Weedman who descend from **Christian Weedman, Jr.** of Grayson Co., KY; **Freeman Jesse (Jim) Weedman** who descends from **Jacob Weedman** of Southern Indiana, and **Robert Harold Widmann** who has roots back to **Lienhard Widmann** born 1606 in Aidlingen, Germany.

**William B. Weedman** recently had his sample

tested for 25 sites up from the original 12 sites and the results are no surprise. It shows a close match to the test results to both **Jim Weedman** and **Nick Weedman** with only a single marker that differed from each other.

We reported earlier that the tests show that **Earl Joseph Weedman's** ancestral line differs from those who descend from Christian Weedman, Sr. It is of interest that there is a remarkable similarity in the DNA tests between the three other Weedmans and that of **Robert Widmann**.

Our objective is to ultimately show with some certainty where **Christian Weedman, Sr.** originated and to possibly make connections with descendants of his siblings and/or parents.

## Betsey Weedman Daughter of Olaf Weedman

*(Editor's Note: **Olaf Weedman** was the first of three brothers who immigrated to the U. S. from Ockelbo, Gävleborg Lan (County), Sweden. Olaf arrived in the U.S. in 1855. Most of those researching this line of the family show that he had a daughter, **Betsey Weedman**, who was born in 1845 in Sweden. Attempts to prove there was such a daughter have not been successful until now.*

*The Church of Latter Day Saints (LDS) has a new site in test mode on which there are records presented in a much more detailed form and which provide exceptional information. Use of this site has been instrumental in making progress on the puzzle regarding **Betsey Weedman**. Information contained in an Iowa state death certificate on-line revealed the relationship between **Olaf Weedman** and **Betsey Anderson**.)*

**Olaf Weedman** arrived in the U. S. in 1855 and settled in Galesburg, Knox County, IL which was the home of a large number of Swedish immigrants. He probably arrived with a number of others from his same home area.

Apparently single and perhaps widowed in Sweden, our records show that he married **Brita Andersdotter** on 30 May 1856 in Knox County. Clearly, **Betsey Weedman** could not have been a daughter of this couple.

**Peter Anderson** married **Betsy Wesman** (sic) (**Weedman**) on 18 July 1863 according to Illinois marriage records.

In the 1870 Federal census, the family was shown living in Wataga, Knox Co., IL with **Peter Anderson** (age: 24), **Betsie** (age: 24), **Joseph** (age: 7), and **Mary** (age: 5) in the household. Peter was a farmer.

In the 1880 Federal census, the family was living in the Walnut Grove area of Knox County. **Peter** (36), **Betsy** (35), **Joseph** (15), **Mary** (13), and **Emma** (2) are in the household. There is a gap of 11 years between Mary and Emma and a later census record shows that Betsy lost all but one of her children.

In the 1900 Federal census for Stromsburg, Polk County, NE **Peter A. Anderson** (born in June 1844 in Sweden) and his wife, **Betsey** (born June 1845 in Sweden) are listed. The record shows she gave birth to eight children but only one was living in June 1900.

The new LDS site however revealed information that would have been unlikely to have been found through normal methods. Iowa death records are on-line and we found where **Betsey Anderson** died on 1 November 1911 in Newell, Buena Vista Co., Iowa and was buried on 5 November 1911 in the Stromsburg Cemetery, Stromsburg, NE. In that on-line record, it names her father as **Olof Weedman** but her mother's name is unknown. This tie is beneficial. Betsey's birth date was shown as 25 July 1845 in Sweden.

No record could be found for Betsey Weedman Anderson in the 1910 census for either Nebraska or Iowa.

A search of another extremely helpful web site, Find-A-Grave, has a picture of the tombstone for **Peter** and **Betsey Anderson** to the right of this paragraph.

Equally revealing is the history of the town of Stromsburg, Nebraska. The town was founded by a group of Swedish immigrants from Ocklebo, Sweden who arrived in 1856. Here is what is stated on the town's web site:

*In 1856, 155 people from [Ockelbo, Sweden](#), sailed aboard the vessel 'Carolina' to a new life in America. After several years in Illinois, some of the people decided to move on to the state of Nebraska, with Swedish real estate agent Lewis Headstrom as their leader. Delighted that the landscape resembled their homeland, they chose to name their new town after Stromsburg, a section of [Ockelbo, Sweden](#).*



It appears that **Peter** and **Betsey (Weedman) Anderson** left Knox County, Illinois after 1880 and joined some of their prior neighbors and probably relatives in Nebraska!

**Betsey Weedman** was apparently the daughter of **Olof Weedman** by a marriage in Sweden. The first wife must have died (or possibly they divorced) and **Olof** immigrated to the U.S. with his daughter, **Betsey**. Clearly, the death record proves the relationship between **Betsey Weedman Anderson** and her father **Olof Weedman**.

This article is printed because it helps to clear questions that have lingered about **Betsey Weedman** and it also points to the fact that there are new bits of information being added constantly to aid in genealogical research. The "find" of the Iowa death record for **Betsey Anderson**, daughter of **Olof Weedman** was the missing piece to help finish a genealogical puzzle on this family.

## **William Melvin Weedman (1860 – 1935)** **Son of John Huhn and Minerva Gamble Weedman, Senior**

*(Editor's Notes: The recent discovery of an excellent tool for genealogical research was a site called Find-A-Grave ([www.findagrave.com](http://www.findagrave.com)). The site allows users to enter information on graves, tombstone inscriptions, and the ability to publish information such as obituaries. The site allows one to search for all of a surname nationwide, in a single state or a specific location.*

*We were recently trying to discover listed graves of Weedman family members in Oklahoma and found the graves of a family that we had simply been unable to find.*

***John Huhn Weedman, Sr.** was born in 1796 to **George and Charlotte (Huhn) Weedman** in Fayette Co., Pennsylvania. The family moved to Perry County, Ohio between 1799 and the early 1800s. John married **Rachael Wilson** in Perry County in 1816 and that is where six of their ten or eleven children were born. In 1830, the family moved to McLean Co., Illinois and finally to Farmer City, DeWitt Co., Illinois. Rachael died in 1854 and is buried in Campground Cemetery near Farmer City.*

*John married **Mrs. Minerva (Yazel) Gamble** in McLean County on 3 June 1855. **Minerva Yazel**, born about 1825, married **Jefferson F. Gamble** on July 13, 1845 in McLean County. The couple had one child, **James J. Gamble** born in 1846. Apparently Jefferson Gamble died prior to 1850.*

*John and Minerva had a son, **William Melvin Weedman**, who was born in February 1860 probably in DeWitt County, Illinois. They soon moved along with a number of other Weedman family members to Webster City, Hamilton County, Iowa. John died there in 1868 and the body was returned to Farmer City for burial.*

***Minerva and William Melvin Weedman** returned to live in Farmer City. On September 15, 1870, Minerva Yazel Gamble Weedman married **Major John B. Hicks** in DeWitt County and they lived in Monticello, Piatt County, Illinois. There were no children born to this couple. It is unknown when **John B. Hicks** died but in the 1900 census, Minerva was shown living with her first son and his wife in Piatt County. Minerva apparently died between 1900 and 1910. It is unknown where she is buried.)*

From late 1800 census records, it had been established that **William Melvin Weedman** had survived and was living with relatives in DeWitt County. In 1880, he was living with his half brother, **Zadoc Casey Weedman** and his wife **Rebecca (Wolfe) Weedman**. William was listed as a 23 year old whose occupation was farming.

A marriage record was found in which a **William M. Weedman** married **Kittie M. Markett** in DeWitt County in 1887. Whether this is our man or not is unclear.

For years, the ultimate destiny of **William Melvin Weedman** was unknown.

The use of the Find-A-Grave site while browsing Oklahoma burial records for Weedman family members revealed that a **Mel Weedman** was buried in Square Cedar Cemetery near the small town of Cleo Springs, Major Co., Oklahoma. Also buried there were **Sophia Weedman** (1855 – 1915) as well as **Eva Weedman** (1893-1948) and **Pearl Weedman** (1896-1967). Sophia's name was on the same stone as that of **Mel Weedman** with stones

for Eva and Pearl being separate.

Census research was undertaken and it was found that the family was living in Major County, Oklahoma when the 1900 and 1910 census counts were made. In the 1910 census, the head of the family was **William M. Weedman** age 52 born in Illinois. That clue led to the conclusion that this was our **William Melvin Weedman** who had been "lost" for years of researching.

In the Kansas State census taken in 1895, a listing is found for **Melvin Weedman**, age 36, **Sophia Weedman**, age 38, and **Eva Weedman**, age 2, living in Morton Township, Sedgwick County. This is the county where Wichita, Kansas is located. Morton Township is southwest of Wichita an on the Kansas - Oklahoma border.

In the 1900 census, the oldest daughter, Eva, was listed as being born in March 1893 in Kansas while the youngest daughter, Pearl, was shown as being born in August 1896 in Oklahoma. That record revealed the marriage of **William Melvin Weedman** and **Sophia** had occurred in 1889. It is likely that the couple had married in Kansas or less likely in Illinois. By this time, there were a number of Weedman families who had moved from Illinois and Iowa to several locations in Kansas.

It appears that neither daughter married although one record seems to indicate the youngest did marry although this cannot be confirmed.

This line ends with the death of **Pearl D. Weedman** in January 1967.

The mystery of what happened to **William Melvin Weedman** was solved but work remains to determine his wife's maiden name.

Apparently, **William Melvin Weedman** made his way from Illinois to Kansas and may well have joined some of the other Weedman families in that State. Whether he married in Illinois or Kansas isn't clear but his wife in 1900 had the name Sophia but no marriage record can be found in either state at this time. We note that in 1895 the family was living in Sedgwick County, KS quite close to Sumner County where **Abraham Lincoln (Linc) Weedman** had settled. It is possible that he participated in the fourth Oklahoma land run (September 16, 1893) but his name is not shown on a list of participants that we have been able to locate. It is unclear if that list was exhaustive or partial. In 1910, **William M. Weedman** received title to 80 acres of land from the Federal Government which indicates the possibility of land run participation. Most of those "Boomers" received 160 acres.

We have located the widow of a man whose obituary stated that the couple cared for Pearl Weedman for 18 or more years. We are attempting to make contact to determine if more history can be learned and to find if pictures might be available.

One final note --- **William Melvin Weedman** had a half brother, **James. J. Gamble** who remained in Illinois. James' wife was **Eva Gamble** and it appears that the oldest daughter, **Eva T. Weedman**, was named in her honor. James and Eva Gamble had no children.

The internet and availability of more and more genealogical records will allow more family mysteries to be solved. The Church of Jesus Christ of Latter Day Saints, called the Mormon Church, has just opened a new internet site which has excellent information some of which has never been available on line. More discoveries are possible with additional research.
